Your Excellency,

We write on behalf of our university communities in Italy to express grave concern for Patrick George Zaki, a postgraduate student at the University of Bologna who was arrested on February 7, 2020, and afterwards allegedly subjected to torture, in apparent retaliation for his activity as a researcher and a Human Rights defender.

We respectfully urge you to secure the immediate and unconditional release of Mr Zaki, allowing him to go back to resume his studies at the University of Bologna, and to permit the appropriate authorities to investigate his alleged torture.

Patrick George Zaki is a twenty-eight year old Egyptian student who came to Italy in August 2019, to pursue a master's degree on Gender Studies at the University of Bologna. Moreover, he is a researcher for the Egyptian Initiative for Personal Rights (EIPR), an organization based in Cairo committed to defending Human Rights.

We understand from Scholars at Risk (SAR), an international network of individuals and institutions committed to protecting scholars and promoting academic freedom — of which our universities are members — that Mr Zaki returned to Egypt for a brief family visit in Mansoura and that, upon his arrival at Cairo International Airport, he was stopped by the Egyptian National Security Agency (NSA). He subsequently disappeared for 24 hours. It has been reported that officers arrested and interrogated him for several hours without the presence of his lawyers in an unknown location.

During these 24 hours he was reportedly subjected to physical abuse and torture, including by electric shocks. The next day, the Public Prosecutor of Mansoura ordered his detention on remand for 15 days, detention that was confirmed on February 22 for another 15 days. According to Front Line Defenders, Mr Zaki was accused of 'spreading false news,' 'incitement to protest without authorisation,' 'incitement to violence and terrorism,' and 'calling for the overthrow of the state.'

We further understand from SAR that Egyptian authorities presented a document stating that he has been detained because of an arrest warrant issued in September 2019, but they have not publicly disclosed the evidentiary basis for this decision so far.

In the absence of any information that may clarify our understanding of these events, the facts as described above suggest that Mr Zaki is detained in apparent retaliation for his nonviolent exercise of the right to freedom of expression, protected by the Universal Declaration of Human Rights (article 19) and the International Covenant on Civil and Political Rights, which Egypt has ratified in 1982.

We are gravely concerned by Mr Zaki's detention conditions. We learn from Front Line Defenders that Egyptian authorities limited his contact with his family and with his legal counsel, conditions that may affect the right of due process and a fair trial, according to the Article 10 of the Universal Declaration of Human Rights.

We therefore respectfully urge you to intervene and ensure the unconditional release of Patrick George Zaki, to allow his return to Italy to continue his studies and to open an investigation on his alleged torture.

We appreciate your attention to this important matter and we look forward to your reply.
